II. Type of public order, selected type of order-award procedure and contract price

On 3 April 2012, the Sponsor published through the Public Order Information System a notice on the intended public order entitled "Broadband Dielectric Analyser for RICE" with the file form identification number of 7202011012741. Regarding the expected contract price, this public order fell within the below-limit category as provided by §8 of ZVZ. To ensure the maximum transparency of the order award procedure, the Sponsor chose to proceed using the procedure applicable to the above-limit tender procedure where, in observance of the provisions in §26, section 5 of ZVZ, the subject public order was to be awarded in observance of the provisions applicable to above-limit public orders. Selected therefore was an open order-award procedure as specified in §27 of ZVZ. The subject of the public tender was a broadband dielectric analyser for the Regional Innovation Centre for Electrical Engineering (RICE) of University of West Bohemia in Plzeň including its delivery, assembly, commissioning and training of the future equipment operators.

On 11 January 2013, the Sponsor executed a purchase contract on delivery of a wide-range dielectric analyser with the following applicant:

In reference to the purchase contract executed by the Sponsor and the above applicant, the price payable for delivery of a wide-range dielectric analyser for RICE is CZK 3,148,000.00 net of VAT.

III. Identification data of the applicants excluded from the order-award proceedings and the reasons for such exclusion

No applicant has been excluded from the tender evaluation and order-award proceedings.

IV. Identification data of the selected applicant and the reasons for selection of the best tender

In view of the fact that the Sponsor received only one tender from the selected applicant, being

where this tender was evaluated in observance of the provisions of §76 and §77 of ZVZ as the only tender received, the tender evaluation committee did not have to proceed in observance of the provisions of §79, section 5 of ZVZ as there were no other tenders to consider.

The Sponsor accepted the recommendation of the tender evaluation committee included in their tender assessment and evaluation report and selected, acting in observance of §81, section 2 of ZVZ, the tender submitted by the company Novocontrol Technologies GmbH & co. KG as the best tender.
