I. Subject of the Public Contract, price negotiated in the Contract:

The Public Contract is an above-the-limit public contract pursuant to the section 8 of the Public Contracts Act; the subject of the Contract is delivery of a universal modular-type vacuum deposition system. 



IV. <u>Identification Data of Bidders Disqualified from Participation in the Tender and Reasons of their Disqualification:</u>

The bidder Kurt J. Lesker Company Ltd. was disqualified from the Public Tender, as the Draft of the Purchase Contract attached to the Bid was not signed by a person authorised to represent the Bidder.

The bidder V.S.T. (Services) Ltd. was disqualified from the Public Tender for not documenting basic, professional and technical qualification criteria, and also because the Bid presented by the Bidder did not meet conditions stipulated by the Contracting Authority in its Tender Conditions. The bidder Měřící technika Morava s.r.o. was disqualified from the Public Tender for not documenting technical qualification criteria, and also because the Bid presented by the Bidder did not meet conditions stipulated by the Contracting Authority in its Tender Conditions.







V. Reasons for the Selection of the most Suitable Bid

The Evaluation Commission has declared that the following Bidders meet the statutory requirements as well as Contracting Authority's requirements stipulated in its Tender Conditions according to Section 76, subsection 1 of the Public Contracts Act, and that none of the Bids below represents an Unacceptable Bid as per Section 22, Subsection 1, paragraph d) of the Public Contracts Act:


The evaluation was performed pursuant to the basic evaluative criterion to select the Bid with the lowest Bid Price.
