II. Subject of the Public Contract, price negotiated in the Contract:

On 31st January 2014, the Contracting Authority dispatched a Contract Notification concerning the Public Contract entitled "Measuring Device for Tension and Pressure Uniaxial and Biaxial Mechanical Measurements of Biological Tissues", Public Contract registration number 375495 ("the Contract") in accordance with the Public Contracts Act, section 26, subsection 1(b). The Public Contract is a above-the-limit public contract pursuant to the section 8 of the Public Contracts Act; the subject of the Contract is a delivery of one (1) piece of a measurement system for one uniaxial tension and pressure, and a biaxial tension loading enabling high-precision measuring of forces and deformations including specimen grips, bases or platens, chamber for tests in water including heating system, camera for automatic detection of a measured specimen, software for controlling the measuring device and a computer with accessories.

The price stipulated in the Contract is 3.900.000,- CZK without VAT.

III. Identification data of the selected Bidder:

The following Company was selected from the Bidders: TestResources Inc, 8I-7, address 701 Canterbury Road S., 55379 Shakopee, MN USA.

In this Public Tender, all the Bidders submitting their Bids demonstrated compliance with the qualification criteria as required by the Public Contracts Act and the Tender requirements; therefore, none of the Bidders was disqualified from the Tender for a failure to comply with the qualification criteria. The evaluation commission had not excluded any of the Bids during their evaluation pursuant to the sections 76 and 77 of the Act.

The evaluation commission evaluated the Bids listed in Article I according to the basic criterion specified in the Tender Dossier, i.e. the economic advantageousness of the Bid, and ordered the Bids pursuant to the sum of points assigned to them for individual evaluation sub-criteria defined in the Tender Dossier. The assigned number of points was then multiplied by the weight of individual evaluation sub-criteria to obtain the value of individual evaluation sub-criteria for each of the Bids.







Evaluation of the Bids - result:



The total number of points is a sum of points – values assigned for the evaluation sub-criteria: a) Bid price and b) equipment technical parameters. A Bid receiving the highest number of points was evaluated as the best one by the evaluation commission. The remaining Bids were listed in descending order according to the number of assigned points.
