

WRITTEN REPORT BY CONTRACTING AUTHORITY

II. Subject-matter of the public contract, identification data of the tenderer selected and contractual price

The subject-matter of the public contract is the **supply of a multi-purpose multi-channel electrohydraulic loading system, including the units for supply of pressurized oil, all fixed and variable distribution systems for pressurized oil and all accessories, electronic devices and the control and evaluation software and any other elements required for reliable, safe and environmentally-sound operation** (hereinafter referred to as "the Equipment"). The Equipment will become a key part of the In-Service Strength and Fatigue Life Testing Shop and the Transport Vehicle Components Testing Shop. The Equipment shall be new, fully functional, complete, shall meet all required parameters and its operation shall be supported by electronic control circuits and by fully-fledged software with a licence, ready for full use. The deliverables must be provided together with software licences for both educational and commercial purposes.

On 26 Jan. 2015, the Contracting Authority entered into a purchase contract for the supply of the aforementioned Equipment with the following tenderer:

The price for the supply of the aforementioned deliverables in the above-named public contract according to the purchase contract between the Contracting Authority and the winning tenderer is a total of **CZK 27,499,000, exclusive of VAT.**

III. Identification data of all tenderers and their tender prices

Within the time limit for receipt of tenders in the said contract award procedure, a total of two tenders were submitted by the following tenderers:

IV. Identification data of tenderers who were excluded from the tender procedure and the substantiation of their exclusion

No tenderer was excluded from the contract award procedure.

V. Substantiation of selection of the winning tender

The evaluation committee assessed the qualifications of all tenderers who submitted their tenders, i.e. the committee assessed the compliance of these tenderers with the qualification criteria set out in s. 59 (1) of the PCA.

A qualification assessment report was drafted regarding the assessment of the qualification of tenderers in the contract award procedure pursuant to s. 59 (6) of the PCA.

Based on the results of the assessment of qualification of tenderers and pursuant to ss. 76 and 77 of the PCA, the evaluation committee assessed the tenders submitted by the following tenderers:

In the tender assessment process according to ss. 76 and 77 of the PCA, no tender submitted by tenderers who demonstrated compliance with qualification criteria was excluded.

Based on the results of the tender assessment according to ss. 76 and 77 of the PCA, the evaluation committee, in accordance with s. 79 of the PCA, evaluated the tenders which had not been excluded. They were the tenders submitted by the following tenderers:

The evaluation committee found that (i) these tenders have met the statutory requirements, the tender conditions and the Contracting Authority's requirements as stipulated in s. 76 (1) of the PCA, (ii) none of these tenders were inadmissible tenders, pursuant to s. 22 (1) (d) of the PCA, and (iii) none of these tenders were abnormally low tenders, as stipulated in s. 77 of the PCA.

The evaluation committee evaluated all tenders according to the fundamental evaluation criterion for awarding the public contract, i.e. **the lowest tender price**, as stipulated in s. 78 (1) (b) of the PCA.

The tender submitted by the tenderer No. 2 was evaluated by the evaluation committee according to the evaluation criteria and was found to be the tender with the lowest tender price. The tenders were ranked by the evaluation committee in ascending order of tender prices and were assigned numbers. The final ranking of the tenders evaluated is as follows:

The evaluation committee evaluated the tender with the sequential number 2 submitted by the company **INOVA Praha s.r.o., Company Registration Number: 64940586, with its registered office at Pražská 5/15, 102 00, Praha 10, Czech Republic** according to the fundamental evaluation criterion set out in the tender dossier and found it to be the tender with the lowest tender price. Based on this resolution, the evaluation committee recommended to the Contracting Authority to accept the tender no. 2 as the suitable tender and to enter into a contract with the tenderer who submitted it.

The Contracting Authority made a decision on selecting the winning tender no. 2, as stipulated in s. 81 (1) (b) of the PCA, and on entering into a contract with the aforementioned tenderer.

VI. Definition of the part of the public contract which is intended to be completed through a subcontractor

In response to the requirement stated by the Contracting Authority in the tender dossier, the tenderer, whose tender was selected by the Contracting Authority as the winning tender, did not state in its tender that any part of the public contract would be completed through a subcontractor.
