The above-specified Contracting Authority hereby provides supplementary information to tender conditions for the above-mentioned public contract:

Inquiry No. 1:

I would like to clarify with you some technical specifications:

In the Annex No. 1 to the purchase contract (product's technical specifications and related seller's duties, page 28) I have found some inaccuracies that should be modified:

- Ability to transfer data according to OPC DA specifications – it should be called Ability to transfer data according to OPC UA specifications, because the data transfer is based in this technology on the principles of OPC UA, not OPC Classic
- Ability to process legacy data. It should be called ability to process HAD (historical data access).

Response to Inquiry No. 1:

The Contracting Authority hereby clarifies product's technical specifications shown in Annex No. 1 of the Contract for Software. Inaccuracies might have resulted from Czech to English translation:

One (1) OPC UA server toolkit source code, allowing the user to develop servers according OPC UA technical specifications, with the following features:

- possibility to develop an OPC server for soft PLC control systems (IEC 61131-3 software model supported);
- possibility to communicate data similarly to OPC DA specifications;
- possibility to handle asynchronous events and alarms;
- possibility to handle historical data;
- Software toolkit source code in C/C++ will be provided;

Software toolkit will enable the development of OPC UA servers for both Windows and Linux operating systems

The Contracting Authority would also like to inform you that the contents and the form of bid submission are detailed in the Invitation to Submit a Bid, Section 2. Bids must be submitted in writing in a properly sealed envelope (see section 2.1 of the Invitation), delivered either in person or by mail to the Contracting Authority's address: Západočeská univerzita v Plzni (University of West Bohemia), Univerzitní 8, 306 14 Plzeň, Czech Republic (mail room working hours 7:00 a.m. – 2 p.m.). No other delivery will be considered proper delivery of the Bid. The Contracting Authority is not equipped with electronic systems that would make possible electronic submission of the Bids.

With respect to the above, **the Contracting Authority has decided to extend the deadline for bids' submission in this tender procedure** as follows:


The deadline for bid submission is 31 October 2014 at 1 p.m.
